 - 1. Corresponding Secretary (Felicia): Pass

 - 3. Treasurer (Karen): PayPal has approved the Non-Profit status for LVOA and transactions fee will be at the 2.2% rate. A printout of PayPal transactions is included in the Treasury Report. There will be a line item of donations without individual names. Since PayPal is easy to use individuals/groups are encouraged to make donations via this method. There is a memo area to indicate the reason of the donation. Note: IG financial assistance is available for any group needing assistance with paying for meeting space.

Resident Agent status: A new Resident Agent name is required since the current name of record is of a member who is no longer with the LVOA Fellowship. Since a name change will need to be submitted there is an additional cost (approx. \$70). There is an annual payment of \$50.

Discussion on the responsibility of the Resident Agent ensued. Noted responsibility is to be a contact for any State concerns, e.g., State mailings. There is no known legal liability involved. It was felt that it be a member with long term program.

Donations of support to the six meeting rooms update: There has not been any direct responses. Three checks have been cashed, one is processing and two have had no process. There is \$1,009 in Prudent Reserve and the Event account has \$1,042.

NSB letter received requesting documents for the Prudent Reserve account. Cheryl will contact the bank for follow up (Karen will send her the info).

- 5. Board Advisor (Cheryl): The Review Committee has started reviewing the Bylaws and Policies. Changes (mostly routine) will be presented when review is completed. One item for the IG to consider is the positions term limits. i.e., people are eligible for two one-year terms. Should there be a break for a person serving in the same position (after serving two terms) or would the person not be allowed to serve in the position ever again? If a break is recommended, how much (1 year, 2 years) of a break? Discussion of establishing a "career pathway" ensued, e.g., Vice Chair would automatically step up to the Chair position. It was felt that it is hard enough to get eligible and willing members to volunteer their time, to leave the process as it is for now. It was reminded that a full membership vote is required for approval of the updated Bylaws and Policies.

All reps are encouraged to ask their groups to register if not already done. Any f/f meetings that went ZOOM need to register at WSO.
