4. Delegates (Hudson, 1-R3 Carole-2-WSBC & Bernadette-Alt 1, Vacant - Alt 2):

Hudson – Attended R3 Assembly last month (3/19-21). There was some discussion about having the Assembly on Friday to allow representatives to attend the convention on Sat & Sun but there was no definite decision. Representatives discussed ways to advertise OA. Tucson is hosting (virtually) the Fall 2021 (8/20-21) Assembly. The Spring 2022 Assembly needs a host. Fall 2022 will be hosted by Northern Colorado. Spring 2023 is open for hosting. There is no PIPO Chairperson. R3 has 20 Intergroups and 421 groups. One Texas Intergroup was lost due to COVID. One Bylaws change was passed to authorize voting virtually. Hudson has been forwarding E-blast emails to Felicia for distribution to LVOA fellowship. R3 donated \$10,000 to WSO to help with the upgrading of the website and translations. WS Convention is scheduled for this August.

Carole – Things for WSBC are ramping up for her on the Subcommittee of the Bylaws Committee for the WBSC. There will be no guests allowed - this is to keep things simple

for voting purposes. Tools Brochure is being updated to change out the pronouns to they/them.
