- F. General Business: -
  - 1. Chair Ellen read the Region 3 appeal letter
  - 2. Vice Chair Vacant
  - 3. Corresponding Secretary-April -passed
  - 4. Recording Secretary Karen- passed
  - 5. Treasurer Carole Reported LVOA contributed \$1800 to WSO during 2023, 2 LV groups contributed directly to WSO as well (for a total of \$1888). Asked if anyone was in need of a reimbursement from the convention, and if so, send a picture of the receipt to her. April reported that one member was reimbursed by Beth (Treasurer for R3) at the convention. March Treasurer report accepted as presented.
  - 6. Delegates April Assembly met on Friday. Region 3 asked that we keep meeting lists up to date. Money is available to help facilitate spreading the message. The Trustee's term is up, no new Trustee yet. Region 4 has dissolved and 4

It was suggested that the gift cards be given back to the meeting that donated them so they can decide what they would like to do with them.
